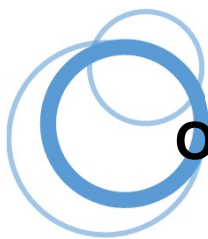

Present in 48 countries, GMNI offers its customers proximity and availability around the world.

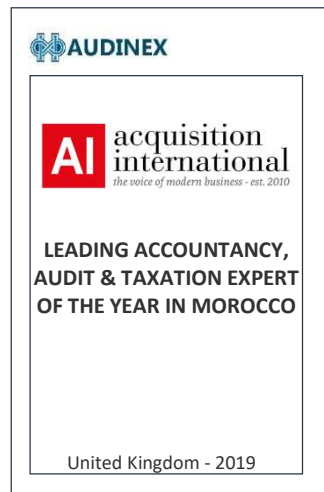
In 2020, GMNI achieved sales of USD 273 million and includes more than 187 professionals.
